1. Call to Order at 6:07
  - 1.1. Members present: Scott Wadland, Adam Freudberg, Tracey Bryant
  - 1.2. Members absent: Tiffanie Maskell
  - 1.3. Others present: Rochelle Santos (Media and Communications Manager)
2. Public Comment
  - 2.1. Amanda Shepherd - field trip are great experiences for students
  - 2.2. Paul Sullivan - suggested that field trips should comply with Title IX, suggested that Internal Work Group violates OML, concern about social media restrictions violating free speech
3. Policy Discussion
  - 3.1. Student Travel (IJOA: Field Trips, IJOA R-1: Standard Field Trip Regulations, IJOA R-2 / JJH-R: Student Travel Regulations Including Overnight and Out-of-State Travel, IJOA R-3: Field Trip Emergency Forms, JJH: Student Travel)
    - 3.1.1. Mr. Wadland suggested the need to add very specific language regarding what is supported and not supported by the School Committee
    - 3.1.2. Mr. Freudberg raised the question of should the School Committee have to approve trips. Discussion focused on potentially approving trips that involved overnight travel or missing school days.
    - 3.1.3. Next Step - Ms. Piasecki to follow up with State Ethics Office regarding teacher benefits

- 3.2. Social Media (FPS Social Media Guidelines, BHE: Use of Electronic Messaging, IJNDB: Empowered Digital Use, IJNDD: Policy on Facebook and Social Networking Web Sites)
  - 3.2.1. Ms. Santos gave an overview of the use of Archive Social - archives social media posts so that they can be provided in response to public records requests
  - 3.2.2. FPS Social Media Guidelines (Terms of Use) - we can moderate content and block users without interfering with free speech
  - 3.2.3. Recommendation from City Solicitor's office to have Facebook pages for School Committee members separate from School Committee campaign pages (e.g. "Scott Wadland, Framingham School Committee - District 3" vs. "Scott Wadland for Framingham School Committee - District 3"). Official School Committee member pages can then be archived using Archive Social
  - 3.2.4. Facebook restrictions on pages belonging to groups - may be lifted in near-term - this would allow SC members to post in discussion groups using their official page vs private account
  - 3.2.5. Next steps
    - 3.2.5.1. BHE - USE OF ELECTRONIC MESSAGING BY SCHOOL COMMITTEE MEMBERS - should be modified to address City Solicitor's recommendations (School Committee)
    - 3.2.5.2. Set up Archive Social (Rochelle Santos) and configure official SC pages
    - 3.2.5.3. IJNDD - POLICY ON FACEBOOK AND SOCIAL NETWORKING WEB SITES - Internal workgroup to draft recommendations for Policy Subcommittee to consider
