RESIDENCY AFFIDAVIT TO SHOW PROOF OF RESIDENCY IN FRAMINGHAM

Any applicant for the Framingham Public Schools who cannot produce required residency documents in his/her own name must ask the owner or lessee of the property where the applicant lives to complete <u>Section I, sign and have this affidavit</u> notarized. The following two documents are required:

- 1. A current mortgage, tax bill, or lease and
- 2. A recent utility bill (cable/satellite TV, electric, gas, water, home/renter insurance) within 30 days and Valid photo identification will be required for notary purposes
